ne of our key commitments in our Council Strategy is creating thriving, healthy households, where children, voung people and their families and vulnerable adults live healthy, active and independent lives. As local authority budgets continue to be under immense pressure due to inflation and rising demand for social care services, in Hillingdon we are always looking at more innovative and efficient ways we can continue to deliver our outstanding services. At the council's Cabinet meeting in September, we were pleased to approve two key reports that are set to deliver more modern, efficient and joined-up services for children, young people and families in the heart of their communities. Helping people on low incomes get online

The council has joined forces with the Good Things Foundation to ensure residents on low incomes are digitally enabled by providing with them with free SIM cards and/or monthly top-ups through the National Databank Project.

Staff in eight of our libraries (Botwell Green, Charville, Harefield, Northwood Hills, Oak Farm, Uxbridge, Yeading and Yiewsley) are helping to distribute free SIM cards and monthly top-ups from participating networks['] Virgin Media O2 and Vodafone.

To receive free data through the partnership, users must be aged 18 and over and live in a low-income household with no access to the internet at home, or insufficient access elsewhere.

Cllr Eddie Lavery, Cabinet Member for Residents' Services, said: "Nowadays, having mobile data is vital to carrying out a range of tasks, such as banking, applying for jobs and accessing essential services. "We hope that our work with

Driver fined for stolen badge use

A van driver has been ordered to pay almost £2,000 after being caught misusing a Blue Badge to park in Uxbridge.

Craig Smith, 48, of Lampard Grove, Stoke Newington, was fined for Blue Badge misuse at a hearing at Uxbridge Magistrates' Court on Tuesday 3 October, following an investigation by the council's counter fraud team.

The court was told that on Friday 26 May 2023, members of the counter fraud team were taking part in a Blue Badge exercise in Uxbridge High Street when they noticed a blue Ford van parked on a single yellow line opposite the Underground station with a Blue Badge displayed on the dashboard.

When questioned, the driver told the council's officers he worked for Pinewood Studios and had dropped off a female passenger who had given him the badge to display before she went into the shopping centre 20 minutes earlier, the court heard.

The counter fraud officers ran details of the badge into a nationwide database which listed it as 'stolen and replaced' on 8 February 2022. Smith was unaware officers had this information.

As the Blue Badge holder was not present, Smith was issued a Penalty Charge Notice for illegally parking on a single yellow line, which was later paid for with a bank card registered in his name on 8 June 2023.

Smith was fined £660 and ordered to pay a victim surcharge of £264and the council's costs of £1,030.

Company fined £5,000 for noisy works

A construction company has been fined £5,000 after council officers caught builders carrying out noisy works outside permitted hours.

The council prosecuted Westway Construction Limited, of Boston Road, Hanwell, following reports builders had been carrying out noisy and heavy-duty building works at a site on Newport Road, Hayes.

The case was heard at Uxbridge Magistrates' Court on Tuesday 12 September, where the company faced a charge of failing to comply with the requirements of a Control of Pollution Act notice.

The court was told the notice was issued on 1 November 2022 following complaints about noise nuisance from the site. The notice required that work at the site could only take place between 8am and 6pm, Monday to Friday, and from 8am to 1pm on Saturdays and that no work could take place on Sundays or bank holidays.

Following further reports of noise, council officers visited the site at around 9am on Sunday 19 February, and witnessed drilling and banging, and builders working on the upper floors in clear breach of the notice.

Cllr Eddie Lavery, Cabinet Member for Residents' Services, said: "We're committed to doing all we can to create safe and strong communities where residents can enjoy a good quality of life.

"Rogue businesses like this not only flout the rules but also impact adversely on the lives of residents living nearby. We won't allow that to continue and will take the strongest action wherever possible.

"I hope this case serves as a warning to others to abide by the rules, or risk paying the price."

Along with the fine, Westway Construction Limited was also ordered to pay the council's costs of £521.44. You can report noise nuisance at www.hillingdon.gov.uk/loud-noise.

Could you sponsor a tree in your area?

Residents are being encouraged to consider sponsoring a tree in time for the winter planting season.

As part of the council's ongoing partnership with the national charity Trees for Streets, residents can apply to have a tree planted outside their home, local school, or in a park or green space.

A total of 137 trees were planted across the borough in 2022/23, featuring a range of species including lime, maple, birch and cherry.

Helena Wright and Adrian Fenton (pictured right) sponsored a cherry tree which was planted outside their home in Ruislip in February.

Helena said: "When we moved to the area, we were keen to have more trees outside our new house for shade, clean air and to have a greener view from our windows.

"I would definitely recommend Trees for Streets to other people. We really need more trees across the country to help bring down temperatures, stop flooding and pollution and address climate change. Plus, in a few years it will look great.

Revamped tennis courts for Harmondsworth residents

On Friday 29 September, the council celebrated the opening of Harmondsworth Recreation Ground's newly renovated tennis courts.

This marked the completion of a £240,000 investment programme, which saw the council invest £60,000 and secure a £181,175 grant from the Lawn Tennis Association (LTA) and the government to revitalise 15 of the borough's tennis courts.

Cllr Eddie Lavery, Cabinet Member for Residents' Services, and Cllr Jane Palmer, Cabinet Member for Health and Social Care, attended the launch event alongside the Mayor of Hillingdon, Cllr Shehryar Ahmad-Wallana and 120 children from Harmondsworth Primary School.

LTA accredited coaches set the children fun tasks, including ball bouncing, running exercises and practising racquet skills.

Clir Lavery said: "It was brilliant to see so many local children enjoying our renovated tennis courts.



"It's important that we all have the opportunity to live healthy, active lives, and exercise is central to both mental and physical health.

"Our partnership with the LTA has helped to revive tennis facilities across the borough and we hope it encourages more people to come along and give the sport a go."

West Drayton Station public realm works due to start

The council will commence works to improve the public areas and car park at West Drayton station this autumn despite the ongoing closure of Station Approach to buses.

This investment, in conjunction with TfL, will see attractive improvements to the station environment, including additional cycling stands, new paving, seating, and landscaping outside the train station. Improvements will be initially carried out behind the station before moving to Station Approach.

Network Rail, which owns the road, has notified the council that they have had to delay their planned repairs to this area into 2024. This is because there needs to be detailed investigations into the ongoing issues with the sewer that runs below the forecourt and bus stand area. This survey is expected to show whether specialist repairs are required. As a result, Network Rail have informed the council that Station Approach will remain closed to buses until the repairs are completed.



Network Rail has apologised for the further delay and ongoing inconvenience to residents while this issue is being resolved, however the council has reiterated its extreme disappointment with the situation, formally requested an earlier resolution and will continue to press Network Rail for this.

Cllr Jonathan Bianco, Deputy Leader and Cabinet Member for Property, Highways and Transport, said: "We were disappointed that we couldn't commence these improvement works in July as originally planned but now the council's work is underway, we are proud to deliver a much improved and welcoming experience for residents using the station.

"While we appreciate that the problems with the sewer are complex and require careful attention, the prolonged inconvenience of the road closure to residents is not acceptable, which is why we're urging Network Rail to carry out this work to a quicker schedule."

Director of Hayes cash and carry store fined £66,000

A store specialising in imported foods has been fined after breaching hygiene conditions and causing unnecessary suffering to animals following a rat infestation.

Asian African Foods Ltd, trading as Krishna Cash & Carry, was sentenced at Uxbridge Magistrates' Court on Friday 6 October.

Company director Santhirasegaram Ketheeswaran had admitted five breaches of food hygiene regulations, causing unnecessary suffering to rodents and failing to comply with a health and safety improvement notice when he represented Asian African Foods Ltd at the same court, on Tuesday 22 August.

The court was told the council's food and health and safety team made an unannounced visit to the business on Uxbridge Road, on 9 June 2022, following complaints from customers regarding the unhygienic storage of food.

The team discovered very poor levels of cleanliness throughout, with dirt, food debris, flies and rat droppings, and the structure of the building was in such a state of disrepair that multiple holes allowed rats to freely enter the business.



The court heard the inspectors found a dead rat beneath a pallet of rice bags and in the rear stock room an emaciated rat was found barely alive while stuck to a glueboard, next to another dead rat, indicating the boards were not being checked regularly.

Electrical sockets behind freezers were hanging off the wall.

Conditions were so appalling that the business was voluntarily closed for cleaning and repair, but when inspectors returned the next day they also found a fridge that had no power, and resulted in the disposal of 40kg of decaying and rotten fish. The court heard Krishna Cash

& Carry had a history of pest

infestations with pest control records showing evidence of rats being treated previously in February, March, April (twice) and May of 2022.

Cllr Eddie Lavery, Cabinet Member for Residents' Services, said: "While the council is committed to creating a borough where residents feel safe and can live healthy lives, this horrifying case serves to show not everyone has the same sense of duty. "I thank our food and health and

safety team for their diligence in following up residents' complaints and ensuring this business was quickly brought into line through a strong prosecution and very significant fine."

For the five hygiene offences, relating to pest control, food storage and cleanliness, Asian African Foods Ltd was fined £60,000 (£12,000 on each count).

For the animal welfare offence, there was an additional fine of $\pounds 5,000$.

For failing to comply with the terms of the health & safety improvement notice there was a further fine of \pounds 1,000.

Asian African Foods Ltd was also ordered to pay the council's costs of £11,296.75 and victim surcharge of £190.



New pothole repair system rolled out

Repairs of potholes and uneven road surfaces across the borough have been revolutionised following the council's adoption of a more efficient and cost-effective process.

Introduced in October, the new road-repair material helps prolong the life of the borough's roads and is a more environmentally conscious method of repair.

The system uses a fast-setting waterproof liquid called 'Elastomac' which is quicker to install and roads can be reopened just 10 minutes after the repair. The system uses 80 per cent less energy than traditional asphalt repairs, uses 85 per cent less carbon and halves the overall costs of repairs.

The transition to a quicker and more cost-effective and sustainable repair system will enable the council's highways repairs team to work far more efficiently, with less disruption for residents and road users while contributing to the council's pledge to reduce its carbon footprint.

Cllr Jonathan Bianco, Deputy Leader and Cabinet Member for Property, Highways and Transport (pictured right), said:

"This is exactly the sort of innovative approach to tackling an age old problem we've adopted as part of our commitment to being a modern and efficient council, dedicated to creating a more climate-friendly borough.

"This repair system uses recycled materials, reduces time, energy, costs and the council's carbon footprint, while also minimising disruption to the road network for motorists. It also enables us to tackle smaller highways repairs quickly, before they become more problematic."

Traditional pothole repairs can be time consuming and energy intensive, relying heavily on fossil fuels. The hole needs to be widened and filled with asphalt which is then compacted down.

Elastomac is a made from 70 per cent recycled materials, including road surface shavings and car tyres. This is poured directly into a pothole with no need to widen it, no compaction needed and there's no waste to remove as there's no excavation. To find out more about highways

Plans for new family-style' children's home are approved

On Thursday 5 October, the council's Planning Committee approved plans to remodel Charville Lane Children's Home in Hayes to replace the current building with six family-sized homes as part of a new model of care for the borough's most vulnerable children.

The existing site will be demolished and replaced with a mixture of one-bed, two-bed and three-bed homes which will provide care and support for up to 12 children.

Each property will be built to look and feel like a family home with its own bathroom, kitchen/dining area, lounge and separate ensuite bedroom so a member of staff will be on hand to provide stability, support and targeted intervention for children with complex needs.

The new family-style homes have been designed to face each other and will benefit from a communal garden in the centre. A separate building will also be built to accommodate educational and enrichment activities.

In Hillingdon, there is currently more demand for residential beds in smaller homes and the layout of the current children's home does not align with how the council wants 21st century children's provision to look.

Clir Susan O'Brien, Cabinet Member for Children, Families and Education, said: "The new homes will allow us to change the way we meet children's mental and emotional needs whilst they are being looked after, by providing them with a safe and stable environment within the borough.

"We want to ensure that these homes provide a caring and supportive setting, so that each young person is given opportunities to grow, learn and develop."

Work is expected to start in December and complete in spring 2025. Children currently living in the home will be moved to other accommodation within the borough.

West London's first council-managed accessible cycle hub

In October, the council opened an accessible cycle hub in Uxbridge which will give people with health, learning and physical conditions the opportunity to use six specially adapted cycles.

The facility, at Pield House School, offers use of the new cycles on the school's cycle track. Students at the school, 12 other special educational needs schools in the borough, local organisations that work to improve residents' mobility and wellbeing, people living with dementia and their carers, and adults and young people with disabilities will all benefit through use of the hub.

The Mayor of Hillingdon, Cllr Shehryar Áhmad-Wallana, and Cllr Jonathan Bianco, Deputy Leader and Cabinet Member for Property, Highways and Transport, were

joined by staff from the school and members of the council's dementia friendly cycling group to celebrate the launch of west London's first council-managed accessible cycle hub and try out the cycles.

The £57,000 council-funded project not only provides specialist cycles and storage facilities, but also cycling instructors who will facilitate sessions, as necessary.

Cllr Bianco said: "I am delighted to support this wonderful initiative, which not only creates immediate opportunities for those who will benefit from the facility, but will also open up horizons and awaken opportunities that cycling can offer in terms of exercise and a sense of personal freedom.

Underused homes to be repurposed for the homeless

Two council buildings previously used for sheltered accommodation will be changed to create vital housing for homeless people.

The council's Cabinet met on Thursday 12 October where it was agreed to decommission both Yiewsley Court in West Drayton and The Gouldings in Uxbridge.

The decision follows a recent review of the council's housing, which revealed a surplus of homes dedicated to older people. The review showed 16 per cent of the council's housing stock was allocated to those over 55.

By decommissioning the two buildings and relocating residents to suitable alternative accommodation in the borough, the two sites can be made available to meet the housing needs of other priority

groups. The Gouldings comprises 42 self-contained one-bedroom flats and Yiewsley Court has 25.

The council consulted with all residents affected by the proposals earlier this year, before putting the decision before Cabinet.

Increasing the council's provision of homes set aside specifically for homeless households whom the council owes a statutory duty to house will help address both supply and cost pressures associated with temporary accommodation.

Cllr Jonathan Bianco, Deputy Leader and Cabinet Member for Property, Highways and Transport, said: "We're committed to creating a borough with happy, healthy households where residents can thrive

For residents who will have to relocate, the council will be providing them with one-to-one support from a council officer throughout the process as well as financial compensation to cover the costs and disruption.

Former director of noisy Ruislip bar fined for infestation

The former director of a Ruislip bar has been ordered to pay more than \pounds 9,000 after failing to address a cockroach infestation and breaching conditions relating to noise nuisance.

Nikhil Walia, 38, of Kingsend Court, Ruislip, former director of Masala Gallery Limited, trading as Kho Kho restaurant and bar admitted four breaches of food hygiene regulations and two breaches of the conditions of his licence when he appeared at Uxbridge Magistrates' Court on Tuesday 12 September.

The council's food and health and safety team made an unannounced visit to the bar in July 2022, following a complaint a customer had found a cockroach in their meal.

The team discovered poor levels of cleanliness throughout, with ready to eat food stored uncovered in areas where there was evidence of live cockroaches and there were also maintenance issues, including

Leader of the Council, Cllr Ian **Edwards,** said: "These awards continue to highlight the incredible levels of commitment and compassion being shown by those volunteering their time in communities across the borough. "These extraordinary residents are the very fabric of our borough,

an open drain with stagnant standing water. The council's officers considered the conditions to pose an imminent risk of injury to health. The court was told Kho Kho had a history of pest infestations with pest control records showing evidence of cockroaches being treated in both September 2021 and February 2022. In July 2022, a judge granted a Hygiene Emergency Prohibition Órder preventing Kho Kho from operating as a restaurant, but this order was lifted by the council in July 2022 following evidence that the health risk had been removed. During the same hearing, the court was told how the council's out of hours nuisance team had received a call from a neighbouring resident complaining of amplified noise coming from Kho Kho at around 11.40pm on 14 January 2023. The council attended the complainant's property 45 minutes

later and witnessed loud, disruptive music with repetitive bass noise.

In January 2022, the council's Licensing Sub-Committee agreed to reduce the hours of Kho Kho bar and restaurant's regulated entertainment, to end at 11pm, following complaints from neighbouring residents of late night noise dating back to summer 2019.

The court was told Walia admitted knowing this restriction and later blamed a customer for using the bar's iPad to play the music – which the staff could then not locate to stop it.

For the four hygiene offences, relating to pest control, food storage and cleanliness, Walia was fined \pounds 1,538 and ordered to pay a victim surcharge of $\pounds615$ and the council's prosecution costs of £4,877.

For the two licensing offences, there was no separate fine, but Walia was ordered to pay the council's costs of £2.472.

Improving our older people's wellbeing

In September and October, we hosted two events to highlight the support and activities available to help residents stay safe, healthy and independent as they get older. Find out also how our Older People's Assembly gives local people a say in how services can be improved.

n Tuesday 26 September, our Day of the Older Person event was held at the Pavilions shopping centre, Uxbridge. tried walking football and Boccia, a popular seated bowls game.

Recycle right this Christmas Dry recycling

You can recycle cards, wrapping paper, books, magazines, paper, cans, glass, cartons, plastic and glass bottles.

Anything with glitter and foil cannot be recycled, so please put these in black waste sacks. Contaminating a recycling bag with items like these could lead to a whole batch being rejected and

disposed of as general waste.

Food waste

Food waste can be recycled by residents of houses and maisonettes with private gardens, and some council-owned blocks of flats, using the kitchen caddies and liners provided by the council.

But getting creative in the kitchen to use up leftovers, rather than throwing them away, is the greenest and most cost-effective option of all.

Christmas trees

You can recycle your real Christmas tree with our usual garden waste collections.

Like your other waste and recycling bags and caddies, it should be visible to crews and placed at the edge of the property boundary on the day of your collection.

All decorations and pots must be removed and trees more than six feet tall must be cut in half.

If you live in a flat, collections are available between Monday 8 January and Sunday 21 January and can be requested by emailing wastesupervisor@hillingdon.gov.uk.

Trees should be placed next to your bin store or collection point for waste and not blocking access to bins.

Greener way to dispose of old gadgets

Creating a brighter future for Hillingdon's families and young people

The council has approved two key strategies which will deliver more modern and joined-up services for children, young people and families in the heart of their communities

he council is committed to creating thriving, healthy households, where children, young people and their families live healthy, active and independent lives. In September, the council's Cabinet agreed a new Youth Offer for Hillingdon's young people and to roll out a family hubs model boroughwide which will enhance support for families.

New, fun youth programme on the way

A dynamic and exciting new Youth Offer will be launched next year which reflects the diverse, flexible needs of today's young people and encompasses the development and activities young people in the borough have requested.

A nine-week public consultation on the proposed offer took place in spring and early summer, and feedback from young people, families, carers,

and partner agencies endorsed the council's modern approach.

The strategy sets out how the council will move from a static buildings-based model to a more flexible way of delivering services local to young people in the heart of communities, by using existing council buildings and new, state-of-the-art family hubs. This will be delivered alongside

more street-based youth work and further outreach work.

The new Youth Offer will create a wider programme of more modern, relevant opportunities, including digital services. It will also complement wider early help and prevention arrangements to support all young people. The number of services provided will increase, offering more opportunities at flexible times to support personal, social and educational development, and improve wellbeing.

A digital service directory will also be created, listing all council and

community youth services in one place.



Family hubs to support whole families

Family hubs will be rolled out boroughwide to provide enhanced support for families within their local communities.

The decision followed an extensive 12-week consultation on the council's proposed Family Hubs Strategy.

Respondents positively received the proposals, welcoming the introduction of one system to provide all the support families might need from pregnancy through to adulthood.

What are family hubs?

Our Family Hub Strategy reflects the government's national programme of providing more integrated services to whole families, parents, carers and children aged 0 to 19 and up to 25 years of age for those with special educational needs (SEND).

Hillingdon's family hubs

Hillingdon opened its first family hub in Uxbridge in December 2021, and our ambition is to now expand this model boroughwide, building on existing services, such as children's centres, to offer more joined-up support to older children and young people.

Six family hubs and additional delivery points will be at the centre of local communities in existing children's centres, libraries, community spaces and leisure centres.

Family hubs and additional sites will be within 1.5 miles or 30 minutes' walk from residents' homes.

'I became a Shared Lives carer, and I have never looked back'

Do you have space in your heart and room in your home? Because that's all it takes to be part of the council's Shared Lives scheme, according to one carer who opened his home to care for vulnerable adults.

or more than 35 years, the council's Shared Lives Scheme has helped residents to share their homes with someone who needs care and support.

The scheme provides care for adults and young people (aged 16 and over), including people with learning difficulties, mental health needs, physical disabilities, or older people.

It can be a full-time caring arrangement as an alternative to living in a care home. Or carers can help by providing respite care – giving other families a break, either for a week or two, a weekend, or just overnight.

Khem's story

Khem Ramjuttun from Hayes, left a full-time job in a care home

to become a dedicated Shared Lives carer five years ago

He said: "I lived next door to a wonderful man who had been a Shared Lives carer for many years. I saw the difference he made to people's lives, and I wanted to do the same.

"I was already working in a care home, which I loved. My dad, Raj, who's been a nurse for many years and I used our experience of working in care services to design an extension to the house. I became a Shared Lives carer and I've never looked back.

"You get lots of training and support from the council's Shared Lives team, social services officers and therapists to help you take care of the people living with you.

"Anyone can do it. My background helped, but if you're compassionate, caring, flexible and patient you can



learn how to look after an adult and take care of their needs. In much the same way as you get foster carers who look after children, this is very similar and equally important for adults.

"You end up creating this big family, made up of your relatives and the people you care for they become a part of your life.

"If you love caring for people, have space in your home and the

Cllr Jane Palmer, Cabinet Member for Health and Social Care, said: "Schemes such as Shared Lives play such an important

part in supporting adults with additional needs and we'd love to see more people like Khem come forward and offer their support.

"If vulnerable adults are supported in a safe, caring, family environment they can often go on to live independently once they are ready. This scheme is one way we can help them on their journey."

Supporting stars of the future

The council's Tashan Daniel Award scheme continues to nurture the ambitions of talented local young people. *Hillingdon People* met this year's bursary winners hoping to take their sporting and cultural pursuits to the next level.

he funding initiative was created in 2020 in memory of Tashan Daniel who was tragically killed in 2019. Tashan was a keen photographer, footballer and athlete who dreamt of becoming an Olympic sprinter.

The bursary scheme is open to applications from residents aged up to 21 and offers grants which can be used to pay for sports equipment and competitions, gain

qualifications in art and culture and enrol on vocational courses. In September, the judging panel consisting of Tashan's father, Chandy Daniel; Tashan's sister, Oceanna; Cllr Jane Palmer, Cabinet Member for Health and Social Care; and Priscilla Simpson, the council's Sport and Physical Activity Manager met to review this year's applications. Here are this year's winners' stories...

Zara Khan, 13, from Northwood

Zara (pictured below right with Cllr Palmer) has a passion for musical theatre and has landed several roles in past productions, both at her drama club, Future Stars, in Northwood, and at her school. She has performed in a Bright Stars dance ensemble at the Royal Albert Hall and sang in school choirs at St Martin-in-the-Fields in Trafalgar Square.

Her talent has been recognised elsewhere too, with awards from Trinity College London and distinctions in acting exams at the prestigious London Academy of Music and Dramatic Art.

Zara is currently preparing for her Grade 3 exams from the Associated Board of the Royal School of Music. Her ultimate dream is to one day

perform the lead role of Christine Daae in The Phantom of the Opera.

A keen netball player, Zara also plays regularly for her local team, the Newlife Netball Club, and helps develop the younger members.

However, due to recent serious illness in her family she has had to step back from many drama and sports activities and has struggled to continue her singing lessons.

The experience has inspired her to explore the role of drama therapists,

who use drama and arts therapy to build resilience and support children undergoing traumatic events. Zara's parents, Imran and Seema, said the support from the Tashan Daniel Award has given her the opportunity to further develop her own creative talents, along with her ability to act as a mentor to younger children. Zara added: "I am extremely grateful for this award because it will enable me to continue to build my skills in dramatic arts. "I hope to honour Tashan's legacy by excelling in my field, not only to perform on stage but also to use this skill as a drama therapist to support children through challenging times."



Clir Palmer said: "We're so pleased to have been able to support the dreams of two more outstanding young people in our borough in memory of Tashan. "We wish them the very best in their future endeavours and are sure they will do themselves and Tashan's family proud."



Arjun Bhandal, 17. from Hayes

Arjun (pictured above) began practising Taekwondo at the age of 10 and is aiming to reach the top of his sport. The double black belt's talent has won him a place in the British Taekwondo south region poomsae (non-contact patterns) squad.

He plans to apply next year to join the national Talent Draft scheme, which allows athletes to prepare for the Olympic pathway.

Arjun who also recently completed a referee course and is studying to qualify as an assistant coach, said: "I am really delighted and honoured to be a recipient of the Tashan Daniel Award. Tashan's sudden death was tragic, and it had an impact on a lot of people in the community.

"I am grateful that I can, in some small way, help to keep his memory alive through my Taekwondo journey and this award. Thank you to Hillingdon Council and the Daniel family.

"The funding will really help me to be able to compete in more tournaments and ensure I can continue my elite squad training long-term."

The council's annual free-to-enter gardening competitions - the Autumn Show and Hillingdon in Bloom - once again showed off the wealth of green-fingered talent in the borough with a dazzling array of plants and produce.

Autumn Show

The ever-popular growing competition – a highlight in the council's calendar – showcased some barnstorming entries with resident-grown produce and crafts that delighted the judges.

An impressive 459 exhibits were submitted from residents across 57 categories, ranging from best turnips to vegetable or fruit-themed works of art.

Entries were judged by a panel led by Royal Horticultural Society (RHS) and Middlesex Guild Judge, Gerry Edwards; the Mayor of Hillingdon, Cllr Shehryar Ahmad-Wallana; Cllr Jonathan Bianco, Deputy Leader of the Council and Cabinet Member for Property, Highways and Transport, and members of the council's green spaces team, which runs the show.

The judges deliberated for more than three hours in the Great Barn at Manor Farm, Ruislip, on Saturday 16 September before announcing the lucky winners.

One winner was regular competitor, Peter Bird, of Harefield Road, **Uxbridge** (pictured top right), who claimed one of the two 'Best in Show' awards for his 'Two matching cucumbers grown under glass'.

Cllr Bianco said: "The quality of entries this year was of the incredibly high standard we've come to expect from this competition.

"It was a pleasure to judge them and get a real appreciation for the time, talent and great endeavour residents have put into their efforts.

"I congratulate all the winners and entrants for making our decisions so difficult and look forward already to seeing their entries next year."

Peter said: "It feels very surprising actually to get 'best in show', because they [cucumbers] just grow very nicely in our greenhouse.

"We have quite a large vegetable garden and grow all our own produce, it's just a bit of fun and I just like to enter the show."

Peter, who believes the secret to his success is avoiding insecticides and keeping it all organic, also scooped prizes in numerous other categories, including first prizes for both his carrots and onions.

Susan Munro, from Ickenham (pictured right), was awarded second prize in the 'Art (Adult), with a fruit or vegetable theme' category for her incredibly detailed drawing of a cabbage.

She said: "It took a few hours, maybe five or six, but it was fabulous, I loved drawing it and enjoyed the whole process, going to the show and meeting the Mayor."

Illegal vapes, fireworks and a tobacco dog – a day in the life of a Trading Standards officer

Hillingdon People joins the council team keeping residents safe, as they carry out routine inspections on shops in the borough to check they're not selling illegal tobacco.

he men all dressed in black take the backstreets to minimise their visibility and walk with purpose, the springer spaniel in front pulls on its lead, sensing something is about to happen.

Their route to the location and lowkey appearance is by design – if there are any 'spotters' they won't be able to tip-off their mates that Hillingdon's Trading Standards team is in town.

These operations are part of the day-to-day life of a Trading Standards officer and the spike of excitement they provide is the culmination of months of intelligence-led planning.

Today, Hillingdon People joins the team as it carries out a series of unannounced checks at eight locations across the borough seeking out shops selling illegal tobacco – a persistent issue nationwide, including in Hillingdon.

The council doesn't have a dedicated dog handler, so a specialist has been brought in from Wales just for this operation. Pippa, the six-and-a-half-year-old springer is trained to detect illicit tobacco, but more recently has also been trained to detect illegal vapes – an increasingly prevalent issue.

The team conducts these operations regularly across the borough. At the first store, a small shop in Uxbridge, nothing is found.

"That just goes to show, some of the complaints we get may be spurious," says King-Yip Cheung, the council's Trading Standards officer who organised the operation.

He explains that sometimes the tipoffs and complaints the team receives deliver results, but not in this instance. However, King-Yip – who brings 33

years trading standards experience - is confident in success at one of the team's visits later in the day.

"We've done test purchases there, so we know they sell it," he explained. By the end of the day, 1,260 illegal cigarettes were found in three of the shops visited, as well as 100 illegal vapes, with oversized tanks, containing more than the 2ml legal limit.

Depending on the quantity of goods seized and whether the business has prior history of illegal goods, those three shops will get a warning, formal caution or face prosecution.

The council's Trading Standards team has one key ambition – to keep the residents of Hillingdon safe. Their work is vast and varied, from today's operation for illegal tobacco, to investigating sales of dangerous or counterfeit goods, test purchases for underage sales of restricted items, rooting out rogue traders and tackling the aforementioned boom in illegal vapes.

At this time of year, the team is also entrenched in the mammoth



task of ensuring legitimate sales of fireworks from stores across the borough. The team's work here will include processing fireworks storage licence applications and further site and inspection visits.

The team also conducts undercover test purchase operations of agerestricted products throughout the year. This may include products such as fireworks, but also alcohol. vapes, tobacco and knives. All these products can only be bought by adults aged 18 or over.

Of the variety in the role, King-Yip said: "I lead on product safety and age-restricted sales and fireworks safe storage for our team. I also handle other work areas such as misleading claims and descriptions such as clocked cars, weights and measures – ensuring weight and quantity descriptions on products are as stated. I also investigate fake goods and doorstep cold caller scams, such as rogue tradesmen who target the elderly and vulnerable."

The role is highly skilled and requires a broad knowledge of the law and legislation that covers the marketing of goods. There's a lot of paperwork involved, with some investigations taking months and sometimes it can be a year, or more, before the team's endeavours are rewarded with a positive result in court.

The work takes a particular type of person, with huge dedication and minute attention to detail. But the rewards are great.

Eastcote business fined for carrying out under-age vape sale

The directors of an Eastcote newsagents have been ordered to pay more than £8,000 after selling a vape to a 15-year-old and for supplying illegal, oversized vapes.

Narinder and Kartar Lamba, the directors of Eastcote Newsbox Ltd each admitted the two offences when they appeared at Uxbridge Magistrates' Court together on Tuesday 3 October, following a prosecution brought by the council's Trading Standards team.

The court was told the team was conducting under-age test sales using a 15-year-old child on 13 February 2023 and the youth was sold a 1,500 puff 'Blue Razz' disposable vape (pictured right), which contained nicotine, by Narinder Singh who was serving at the Field End Road store. The legal limit for disposable

e-vapes is 2ml of liquid, or around



King-Yip adds: "It is an enjoyable role, both when I'm working on my own, but also the work I do together with the team.

"It is rewarding that our work helps protect consumers from unsafe products and other misleading and illegal practices. And it helps ensure a level playing field for legitimate businesses in the borough who comply with the law."

600 puffs, so the item sold was more than double the limit. If you suspect a business is selling restricted products to under-age shoppers, or selling illegal vapes, you can report it by emailing tradingstandards@hillingdon.gov.uk.



Selling fireworks safely

An annual licence allows premises to store all year, but they can only sell fireworks at the following times:

- between 15 October and 10 November
- between 26 and 31 December
- first day of Chinese New Year and the three days prior
- Diwali and the three days prior.

If a trader wishes to sell outside of the above dates, then they will need to have an all-year selling licence which they can apply for.



Enioving fireworks safely

When buying fireworks, the council's Trading Standards team advises residents to only buy from licensed sellers, both in-store and online.

Do not buy from unknown retailers on social média sites. Remember, it is illegal for under-18s to buy fireworks.

Only fireworks that carry the CE mark or UKCA mark and are correctly labelled with details of the manufacturer and importer can legally be supplied to consumers.

Fireworks cannot be let off between 11pm and 7am, except for on 5 November, Diwali, New Year's Eve and Chinese New Year. To find out more, or report noise nuisance from fireworks, visit www. hillingdon.gov.uk/fireworks.

In September, our annual Kids in Care Awards (KICA) recognised the fantastic accomplishments of our young people in care, and we also launched a new film to inspire more people to become foster carers.

he remarkable achievements of care experienced children and young people were celebrated at the council's funfilled and glamorous annual KICA event on Sunday 17 September.

Four hundred children, carers and friends were brought together to recognise the children and care leavers' determination and successes at the special ceremony at Stockley Marquee at Stockley Park Golf Course.

Those nominating the children and young people for the awards acknowledged them for a range of achievements, including excellence in education, moving into independent living and being involved with the Children in Care Council. Qualities such as resilience, kindness, strength and determination were also celebrated.

The young people walked the red carpet to meet the Mayor of Hillingdon, Cllr Shehryar Ahmad-Wallana, and Cllr Susan O'Brien, Cabinet Member for Children, Families and Education. who presented their awards.

Care experienced young person Beanie (pictured right with fellow care leaver and KICA awardee Lewis) delivered a passionate and inspirational speech about what KICA means to her.

She is 20 years old and now living independently. Since attending KIČA last year, Beanie has been inspired to volunteer with the council's children's rights and participation team, supporting younger care experienced children and helping train council staff in how best to support them. She has also been included on interview panels, helping to recruit new council



social workers and the council's new Director of SEND and Education. Beanie was nominated by six different professionals and presented with a KICA award for her voluntary work. Addressing a packed room, she said: "For us young people, being in care we may face many challenges and get labelled and be judged. For years I let this affect me. I used to be embarrassed and



ashamed but now I am so proud of being in care. I am so proud of the person I have become; of the brothers and sisters I have made and how I have helped other children in care along their journey.

"My life has been like a roller coaster with lots of highs and lows. But I had a team around me who didn't think negatively and who saw my strengths and encouraged me to achieve what I am capable of."

Other highlights of the event included games, face painting, biscuit making, a caricature portrait artist, food trucks, an ice cream van, and arts and crafts.





Cllr O'Brien said: "We are proud of each and every child in our care, and our Kids in Care Awards event is a great way to express not just our pride, but that of our children's carers and contemporaries.

Update from the Neighbourhoods Superintendent

With darker nights drawing in, I wanted to take this opportunity to share with you how your local policing teams will be tackling crime and reducing anti-social behaviour as we move further into winter. Anti-social behaviour and incidents of burglary tend to increase around this time of year, and we recognise that many people, including the elderly and vulnerable members of our communities, can be left feeling anxious and worried. Please be reassured that your local police will be working proactively to keep you all safe during this period.

Officers will be out within communities speaking to vulnerable residents and offering them crime prevention advice, and officers will be undertaking enhanced patrols to ensure safety on the streets of Hillingdon. To supplement the work of your local teams, the Roads and Transport Policing Command in partnership with Transport for London will be carrying out patrols in the borough to prevent disorder on buses and at transport hubs and will be engaging with people to offer them travel safety advice.

Hillingdon, as with the rest of London, can experience an increase in burglaries as the nights draw in and it's important that we are all aware of some basic information and security advice to keep our properties

- safe. Please be aware that: burglaries increase during
- the week with fewer, on average, over the weekend
- burglars are most active between midday and 9pm
- 15 per cent of burglaries are opportunistic - burglars take advantage of open/unlocked doors and windows.

To protect your property from burglars, follow our three-step advice to keep your home safe: 1) protect your valuables 2) safeguard your building 3) secure your outside gates and sheds/garages.

Practical measures you can take to achieve these steps include:

- ensuring doors and windows are closed and locked
- keeping valuables out of sight of windows and letterboxes
- ensuring any mail and/or deliveries are taken in from the doorstep
- securing your garage and shed with robust locks • ensuring any side or back gates
- are closed and locked secure.

t's not too late to protect yourself this winter with the COVID-19 booster and flu vaccines. Both are available for free to those who are at risk of becoming seriously ill if they contract the viruses.

This means that people over 65, residents of care homes and people in clinical risk groups, including people who are pregnant, are all eligible. Anyone aged 12 to 64 who are household contacts of people with weakened immune systems, carers, and health and social care staff can have both too.

If you're pregnant, getting your flu and COVID-19 vaccines will help protect you and your baby against the viruses. This is important

because pregnancy changes how your body responds to infections, increasing the risk of developing complications if you do get flu or COVIĎ-19.

Both vaccines are proven to be safe to have at any stage of your pregnancy and the protection passes on to your baby for the first few months of their life.

Fighting fraud and protecting the public purse

To mark Fraud Awareness Week (12 to 18 November), Hillingdon People shines a spotlight on the excellent work of the council's counter fraud team and the role you can play in catching fraudsters.

ounter fraud is responsible for investigating a raft of potential frauds and dishonesty offences, including tenancy fraud, giving false information on applications, not declaring income and misusing parking Blue Badges.

Fraud is a serious crime which can have a devastating impact on its victims and negatively impact on the availability of the council's resources.

Update on the team's good work so far in 2023/24

Tenancy fraud and other housingrelated frauds deprives genuinely eligible families of a much-needed home. Through its continued work to investigate and take action where fraud is suspected, the council has so far this financial year prevented the loss of £2.6 million and recovered 48 council properties due to non-occupation, subletting and abandonment.

Following a check of all the council's emergency accommodation to expose fraud, such as non-occupation and false homelessness applications, 19 accommodation placements have been cancelled since April 2023, saving the council £159,000.

More than \pounds 127.000 has also been saved through action taken against people fraudulently receiving financial assistance from the council for adult social care services where they haven't properly disclosed their income, savings or property ownership. Additionally, a further £92,000 has been saved in children's social care as a result of the identification of false applications for assistance. The counter fraud team also includes an onsite Immigration Official who is able to verify documentation and provide up-todate immigration status information for prospective or current council service users. This has prevented a loss of more than $\pounds 68,000$ so far this this year by identifying people no longer eligible for support due to their immigration status. Additionally, the council has prosecuted three people for Blue Badge fraud, which has collectively cost the offenders more than £5,000in fines and costs. Blue Badges are only intended to be used by the holder and misusing them limits the number of accessible parking spaces available to those residents who really need them.



Furthermore, the team's proactive data matching through the National Fraud Initiative highlights cases of fraud or loss across a variety of council services. Through this work, the team has identified cases to the value of £75,000 where people have claimed a single person's discount for council tax when they were not entitled to do so.

In total, this financial year the council's fraud team has identified savings related to fraud and prevented the loss of more £3.4 million through its proactive activity and investigative work.

Cllr Martin Goddard. Cabinet Member for

Finance, said: "The council has a zero-tolerance approach to fraud, bribery and corruption.

"We will continue to investigate all claims of fraud against the council and use the full force of the law to prosecute where we find evidence of fraudulent activity."

We're consulting on how we respond to Automatic Fire Alarms (AFA). Across London, less than one per cent of AFAs end up being recorded as fires. Ninety-nine per cent are false alarms.

We intend to stop attending AFAs between 7am and 6pm (when most buildings will have staff on site who can confirm whether the alarm is genuine) There are exceptions to this.

We'll continue to attend:

- buildings with sleeping quarters (student accommodation, care homes, hospitals, hotels, prisons etc)
- premises that contain dangerous substances under the Control of Major Accident Hazards (COMAH) Regulations
- other non-domestic buildings of substantial public significance where we consider exemption appropriate through our annual assessment of risk.
