1 Introduction

1.1 This report provides consults on the options the Local authority will model when the final Schools Block budget is issued later, in this month with the implementation of the hard National Funding Formula.

2 **Recommendation**

- 2.1 Schools Forum is invited to:
 - a) Note the Options that will be modelled.

3 Background

- 3.1 On 19 July, the Minister of State for School Standards made a writtenstatement setting outinformation on the schools, high needs and central school services national funding formulae (NFF) for 2023 to 2024.
- 3.2 The published information included provisional National Funding Formula(NFF) allocations for Schools Block (excluding Growth), High Needs Block and Central School Services Block for 2023-24, based on current pupil data. Actual allocations and the Growth allocations will be determined laterin the Autumn, based on Autumn 2022 school census data. There was no information on Early Years funding in this release.
- 3.3 For mainstream school funding (the School Block), the ESFA has indicated the intention to continue to move towards a 'hard' national funding formula, with the implementation beginning from 2023-2024.
- 3.4 Changes that are expected to be in place for 2023-2024 include:
 - a) Decrease of the MFG value to between 0.0% and 0.5%
 - b) No local discretion over which funding factors to use

- c) Local factor values must move closer to NFF factor values, with maximum and minimum values in place for factors, further limitinglocal priorities. See Appendix A.
- d) Inclusion of previously separate school supplementary grant into the block funding
- 3.5 Whilst funding allocated to the schools and high needs blocks is distributed to individual LAs using National Funding Formula (NFF), the LA will retain some limited discretion over the local formula in to distributing the schools block to individual schools.
- 3.6 There has been some additional updates on 13th October 2022 and we can expect more adjustments before the final allocation and changes are announced, toward the end of December 2022.

4 Indicative funding for 2023/24 (subject to change)

4.1 The announcement has stated that funding for mainstream schools through the National Funding Formula will increase by 1.6% overall, as compared to 2022/23. Please note these are indicative figures and subject to change.

5 Funding Options Models

- 5.1 The 3 models the Local authority will produce is as follows:
 - a) Hard national funding formula
 - b) 5% away from the Hard national funding formula
 - c) 10% away (compulsory) from the Hard national funding formula

The Local authority has the option of not going directly to the hard national funding formula but must be at least 10% away from the full formula.

Access to the previous Authority pro-forma tool (APT) has been closed now, therefore the impact on schools will be accessed on the actual School block budget which should be available toward to end of this month.

The Local authority will Propose and decide on the final Schools block budget model to use and will consult with the Schools Forum members in the January 2023 Schools forum paper with the model options, impact on each school and a justification on the option chosen by the Authority.
