Hillingdon Council gives notice that it made these experimental Orders under Section 9 of the Road Traffic Regulation Act 1984 on 3rd March 2023 coming into operation on 3rd April 2023 to **introduce parking charges as shown below within Ruislip Lido Willow Lawn Car Park:**

(Amendment No. 4) Experimental Order 2023

Made on 3rd March 2023

Coming into operation on 3rd April 2023

The Council of the London Borough of Hillingdon, after consulting the Commissioner of Police of the Metropolis, in the exercise of the powers conferred by Sections 6, 9, 32, 35 (1 & 3), 124 and part IV of Schedule 9 to the Road Traffic Regulation Act 1984¹ as amended by Section 8 and Schedule 5 of the Local Government Act 1985², the Road Traffic Act 1991³, Parts III and IV of Schedule 9 to the Act and Section 115 of the Highways Act 1980 and of all other powers enabling hereby makes the following Order:-

1. This Order shall come into operation on 3rd April 2023 and may be cited as The Hillingdon (Off Street Parking Places) Order 1985 (Amendment No. 4) Experimental Order 2023.
2. INTERPRETATION
In this Order:
 - a) The expression "Order of 1985" means the London Borough of Hillingdon (Off Street Parking Places Order) 1985 as amended by the Variation and amendment Orders;
 - b) The description "Ruislip Lido – Willow Lawn Car Park" has the same meaning as set out within The Hillingdon (Off Street Parking Places) Order 1985 (Amendment No. 1) Order 2017.

3. AMENDMENT TO THE ORDER

The London Borough of Hillingdon (Off Street Parking Places) Order 1985 shall have effect as though the Schedule for "Ruislip Lido – Willow Lawn Car Park" was substituted by the Schedule as set out within this Order.

4. In pursuance of Section 10(2) of the Road Traffic Regulation Act 1984, the Corporate Director of Place of the London Borough of Hillingdon, for the time being, or some other person authorised in that behalf by him, may, if it appears to him or that person essential in the interests of the expeditious convenient and safe movement of traffic or for preserving or improving the amenities of the area or any road affected by this Order, modify or suspend this Order or any provision thereof.
