Hillingdon Council gives notice that it proposes to make these Orders to:

- 1. Install 'at any time' waiting restrictions in sections of roads as set out in the Schedule to this notice below.
- 2. Install blue badge disabled parking bays at the following locations:
  - i) Outside No. 144 Waltham Avenue, Hayes
  - ii) Outside No. 47 Skipton Drive, Hayes
  - iii) Outside No. 67 Charnwood Road, Hillingdon
  - iv) Outside No. 57 Chaucer Avenue, Hayes
  - v) Outside No. 71 87 Heather Lane, West Drayton
  - vi) Outside No. 309 Victoria Road, Ruislip
  - vii) Outside No. 36 Burnham Gardens, Hayes
- 3. Remove the following redundant disabled parking bays:
  - i) Outside No. 9 Keir Hardie Way, Hayes
  - ii) Alongside No. 222 West End Road in Roundways, Ruislip
- 4. Convert the Zone C1 permit holder parking place outside No. 2 Dellfield Crescent, Cowley to a blue badge disabled parking bay.
- 5. Convert part of the Zone N permit holder parking place outside Nos. 8 and 10 Rofant Road, Northwood to a blue badge disabled parking bay.
- 6. Convert the existing 'Monday to Saturday 8am to 6.30pm' waiting restrictions on the north side of East Way, Hayes to 'at any time' waiting restrictions.
- 7. Convert a section of the existing 'Monday to Saturday 8am to 6.30pm' waiting restrictions on the northeast side of Park Road, Hayes 10 metres either side of the junction with Regents Close to 'at any time' waiting restrictions.
- 8. Convert the existing 'Monday to Friday 8am to 10am and 2.30pm to 4.30pm' waiting restrictions around the central island at the southeastern end of Carlyon Road, Hayes to 'at any time' waiting restrictions.
- **9.** Introduce a section of 'Monday to Saturday 8am to 6.30pm' waiting restrictions on the east side of Long Lane, Hillingdon, between northern boundary of No. 180 Long Lane, northwards for 19.5 metres.
- 10. Extend and realign the no stopping school keep clear markings operational 'Monday to Friday 8am to 10am and 2.30pm to 4.30pm' on Owen Road, Hayes outside Belmore Primary School. New extent along the southwest side of the road, from a point opposite the common boundary of Nos. 25 and 26 Owen Road north-westwards for a distance of 144.24 metres.
- 11. Introduce 'Monday to Friday 8am to 10am and 2.30pm to 4.30pm' waiting restrictions outside Nos. 72 to 80 Wood End Green Road, Hayes.
- 12. Introduce a 40mph speed limit on the section of Rickmansworth Road, Harefield, between the Borough boundary with Three Rivers District Council and the existing 30mph speed limit approximately 80 metres northeast of the northeastern kerbline of Hall Drive. COWLEY CRESCENT, COWLEY – At both junctions with High Road, Cowley.




### STATEMENT OF REASONS


The proposed extension of school keep clear markings and installation of waiting restrictions in various roads is intended to remove obstructive parking to assist free flow of traffic and promote road safety. The introduction of waiting restrictions in the above roads would mean that residents can manoeuvre more safely particularly at the turning points, in accordance with residents' wishes. All proposals have been agreed by the Cabinet Member for Property, Highways and Transport.


The proposed changes of speed limit on Rickmansworth Road, Harefield is intended to enhance road safety without effecting emergency services and improving the safety of all road users.



## Coming into operation XXXXXXXXXXX

The Council of the London Borough of Hillingdon, after consulting the Commissioner of Police of the Metropolis in exercise of the powers conferred by Section 6 and 124 of and part IV of Schedule 9 to the Road Traffic Regulation Act 1984<sup>1</sup> as amended by Section 8 and Schedule 5 of the Local Government Act 1985<sup>2</sup>, the Road Traffic Act 1991<sup>3</sup> and of all other enabling powers hereby make the following Order:-

- 1. This Order shall come into operation on XXXXXXXXX and may be cited as The Hillingdon (Waiting & Loading Restrictions) (Amendment No. XX) Order 2023.
- 2. In this Order the expression "enactment" means any enactment, whether public, general or local, and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Hillingdon (Waiting & Loading Restrictions) Order 2023<sup>4</sup> shall have effect as though:
