Hillingdon Council gives notice that it proposes to make these Orders which will:

- 1. Install 'at any time' waiting restrictions is sections of roads as set out in the schedule to this notice below.
- 2. Introduce a permit holders past this point residents' parking scheme in part of Pond Green, Ruislip (operational between 'Monday to Friday 8am to 10am and 2.30pm to 4.30pm, Saturday and Sunday 10am to 4pm') in which a vehicle may be left during the permitted hours if it displays a valid Zone RM3 permit.
- 3. Establish permit parking places (operational between 'Monday to Saturday 9am to 5pm') in which a vehicle may be left during the permitted hours if it displays a valid Zone H1 permit in Kiln Close, Richards Close, St Paul's Close and St Peters Way, Harlington.
- 4. Establish shared use permit holder and pay & display parking places (operational between 'Monday to Saturday 9am to 5pm') in which a vehicle may be left during the permitted hours if it displays either a valid Zone H1 permit or a ticket within parts of St Peters Way, Harlington.
- 5. Impose waiting restrictions operational between 'Monday to Saturday 9am to 5pm' with sections of 'at any time' waiting restrictions to prevent obstructive parking in Kiln Close, Richards Close, St Paul's Close and St Peters Way, Harlington.
- 6. Remove the Zone HH permit holder parking place outside Nos. 1 and 1a Normans Close, Hillingdon and replace with 'Monday to Friday 9am to 5pm' waiting restrictions to facilitate the installation of new vehicle crossings.
- 7. Establish permit parking places (operational between 'Monday to Friday 9am to 5pm') in which a vehicle may be left during the permitted hours if it displays a valid Zone HN1 permit in Cedars Drive and Bishop's Close, Hillingdon.
- 8. Impose waiting restrictions operational between 'Monday to Friday 9am to 5pm' with sections of 'at any time' waiting restrictions to prevent obstructive parking in Cedars Drive and Bishop's Close, Hillingdon.

RESIDENTS PERMITS - £0 - 1st vehicle, all subsequent - £40 per annum.

VISITORS VOUCHERS - First book of 10 per household per annum- free. £5 - per book of 10 thereafter.

SCHEDULE PROPOSED 'AT ANY TIME' WAITING RESTRICTIONS

JOLLY'S LANE, HAYES - At the northern end of the road adjacent to No. 1 Lapponum Walk.

WHITBY ROAD, RUISLIP - At the junction with Oxford Drive.

OXFORD DRIVE, RUISLIP - At the junction with Whitby Road.

CHURCH CLOSE, UXBRIDGE - All sides of the central island in front of Nos. 8 to 30 Church Close.

BETAM ROAD, HAYES - Northwest side, from a point in line with the northeastern boundary of Milton House. Betam Road southwestwards to the southwestern extent of the adopted highway.

BOURNE AVENUE, HAYES - Extend the existing double yellow lines southwest of the junction next to Cheltenham House by 41.5 metres.

POND GREEN, RUSILIP - Install double yellow lines on the inside of the corner adjacent to No. 34 Pond Green, Ruislip.

MILLS CLOSE, HILLINGDON - At the junction with Cedars Drive.

BUCKINGHAM GROVE, HILLINGDON - At the junction with Cedars Drive.

STATEMENT OF REASONS

The proposed installation of 'at any time' waiting restrictions is intended to remove obstructive parking to assist the free flow of traffic and promote road safety.

The proposed extensions to the Heathrow and Hillingdon Parking Management Schemes are intended to prevent all day non-residential parking and promote road safety.

The proposed Parking Management Scheme in Pond Green, Ruislip is intended to prevent all day non-residential parking and promote road safety.

The proposed removal of a section of permit holder parking place in Normans Close, Hillingdon is intended to provide clear access to soon to be created off-street parking areas.
