2. Impose waiting restrictions operational between 'Monday to Friday 1pm to 2 pm ' with sections of double yellow lines to prevent obstructive parking within sections of the roads as set out in Schedule 1 to this notice.
3. Impose 'at any time' waiting restrictions on the sections of road as set out in Schedule 2 to this notice.
4. Extend the existing 'Monday to Friday 10am to 11am and between 2pm to 3pm Monday to Friday' waiting restrictions in Lawson Gardens, Northwood Hills throughout the rest of the road and install double yellow lines opposite Nos. 11 to 13 Lawson Gardens.
RESIDENTS PERMITS - £0-1st vehicle, all subsequent - £40 per annum.
VISITORS VOUCHERS - First book of 10 per household per annum- free. $£ 5$ - per book of 10 thereafter.
