Hillingdon Council gives notice that it proposes to make these Orders which will:

- 1. Install 'at any time' waiting restrictions on sections of road as set out in the schedule to this notice.
- 2. Install blue badge disabled parking bays at the following locations:
  - i) Outside No. 43 Pinewood Avenue, Uxbridge
  - ii) Outside No. 7 Cedar Avenue, West Drayton
  - iii) Outside No. 3 Priory Way, Harmondsworth
  - iv) Adjacent to No. 55 Harrison Close, Northwood
  - v) Adjacent to No. 36 Dell Farm Road, Ruislip
  - vi) Outside No. 12 Westwood Close, Ruislip
  - vii) Outside No. 34 Flamborough Road, Ruislip
  - viii) Outside No. 105 Bridgwater Road, Ruislip
  - ix) Outside No. 35 Petworth Gardens, Hillingdon
- 3. Convert part of the existing Zone N2 permit holder parking place in the northern most extremity of The Glen, Northwood to create a new blue badge disabled parking bay.
- 4. Formalise the two existing blue badge disabled parking bays outside Northwood Golf Club on Rickmansworth Road, Northwood.
- 5. Remove the following redundant blue badge disabled parking bays and convert back to permit holder parking places:
  - i) Outside No. 37 Mount Road, Hayes
  - ii) Outside No. 22 Brickfield Lane, Harlington
  - iii) Outside No. 16 Burness Close, Uxbridge
  - iv) Outside No. 24 Field Way, Ruislip
  - v) Outside No. 119 Bedford Avenue, Hayes
  - vi) Outside No. 4 Savoy Close, Harefield
  - vii) Outside No. 2 Savoy Close, Harefield
  - viii) Outside No. 53 Berkeley Close, Ruislip
  - ix) Outside No. 73 Berkeley Road, Hillingdon
- 6. Convert sections of existing 'Monday to Saturday 8am to 6.30pm' waiting restrictions in Ryefield Crescent, Northwood wrapped around the corner east of Nos. 14 to 20 Ryefield Court to 'at any time' waiting restrictions.
- 7. Install 'at any time' loading restrictions on the west side of Copperfield Avenue, Hillingdon, from the junction with Pield Heath Road to the extent of the permit holder parking place outside No. 1 Copperfield Avenue.
- 8. Install waiting restrictions operational 'Monday to Friday 9am to 5pm' on both sides of Pield Heath Avenue, Hillingdon.
- 9. Impose a permit holders past this point residents' parking scheme in Turks Close, Hillingdon operational 'everyday 9am to 10pm' in which a vehicle may be left during the permitted hours if it displays a valid Zone TC permit or visitor voucher.
- 10. Install a raised zebra crossing on Copse Wood Way, Northwood outside Sevenoaks Court with a height of 75mm and 1:20 gradient ramps on each approach.
- 11. Extend the length of the parking place outside Nos.17 and 19 Hewens Road, Hayes to the top of the dropped kerb at each end. Convert 6.6 metre bay to 8.6 metre bay.

**RESIDENTS PERMITS** - £0 - 1st vehicle, all subsequent - £40 per annum.

**VISITORS VOUCHERS** - First book of 10 per household per annum- free. £5 - per book of 10 thereafter. ### SCHEDULE PROPOSED 'AT ANY TIME' WAITING RESTRICTIONS

BEVERLEY ROAD, RUISLIP - On all sides of the junction with Bessingby Road. BESSINGBY ROAD, RUISLIP - On all sides of the junction with Beverley Road. BULLSBROOK ROAD, HAYES

- i) The rest of the north side of the road.
- ii) At eastern extremity of the road.
- iii) The junctions between Jehta House, Level 1 House and Ventura House.

RYEFIELD CRESCENT, NORTHWOOD - Around the southeastern extent of the adopted highway of Ryefield Crescent.

TURKS CLOSE, HILLINGDON - At the junction with Harlington Road.

HARLINGTON ROAD, HILLINGDON - At the junction with Turks Close.

NORTHFIELD CLOSE, HAYES - Extend the existing double yellow lines outside No. 2 Northfield Close.

#### STATEMENT OF REASONS

The proposed disabled parking bays are intended to benefit disabled people by providing parking bays for the sole use of "blue badge" holders. Redundant bays will be removed to provide more parking for residents and their visitors.

The proposed raised zebra crossing is intended to enhance road safety on Copse Wood Way outside Sevenoaks Court.


The proposed waiting and loading restrictions will prevent obstructive parking and promote road safety.

The proposed introduction of a Parking Management Scheme in Turks Close, Hillingdon is intended to prevent all day non-residential parking addressing concerns raised by residents who petitioned the Council.




The proposed extension of the Zone HE permit holder parking place outside Nos. 17 and 19 Hewens Road will provide additional parking for residents.



# Copperfield Avenue No Loading "At Any Time"












Turks Close, Hillingdon Proposed Parking Management Scheme






17/19 Hewens Road, Hayes Proposals
