Hillingdon Council gives notice that it proposes to make these Orders which will: **1. Impose 'at any time' waiting restrictions in sections of road as set out in the Schedule to this notice.** 

2. Extend the Ruislip Parking Management Scheme to include Nos. 1 to 9 (odds) Bury Street, introducing a Zone R2 parking place and a short extension of the double yellow lines across the shared dropped kerb leading to Nos. 15 to 19 Bury Street.

**3. Establish permit parking places** (operational between '9.00am and 5.00pm Monday to Friday') in which a vehicle may be left during the permitted hours if it displays a valid H1 permit in Harmondsworth Lane (part), Holloway Lane (part), Monks Way and Priory Way, West Drayton.

**4. Impose waiting restrictions** in Harmondsworth Lane (part), Holloway Lane (part), Monks Way and Priory Way, West Drayton operational between '9.00am and 5.00pm Monday to Friday' with sections of 'at any time' waiting restrictions to prevent obstructive parking.

5. Impose waiting restrictions operational '10am to 11am and 2pm to 3pm Monday to Friday' along both sides of North View, Eastcote between the junction of Ivy Close and the Borough boundary with the London Borough of Harrow (expect where there are existing and proposed double yellow lines).
6. Remove 10 metres of double yellow line in Elmlea Drive, Hayes along the southeast side of

the road behind Hayes Cottage Care Centre.

7. Extend the existing no stopping School Keep Clear markings operational 'Monday to Friday 8am to 10am and 2.30pm to 4.30pm' at the following locations:

i) At the northern end of Gordon Road, Yiewsley

ii) Opposite Nos. 110 to 116 Pole Hill Road, Hillingdon

8. Install additional residents' Zone N permit holder places spaces at the following locations in Cygnet Close, Northwood:

i) Outside No. 23 Cygnet Close (existing bay to be extended by 5.5 metres southwards).

ii) The parking area fronting No. 20 Cygnet Close.

### 9. Install Blue Badge holder disabled parking bays at the following locations:

i) Outside Nos. 55 / 57 Apple Tree Avenue, West Drayton

ii) Outside No. 24 Drayton Gardens, West Drayton (on the footway)

iii) Within lay-by on Freemans Lane fronting Nos. 7 - 18 Park Side, Barra Hall Circus, Hayes

iv) Outside No. 37 Cranmer Road, Hayes

**RESIDENTS PERMITS** - £0 - 1st vehicle, all subsequent - £40 per annum

**VISITORS VOUCHERS** First book of 10 per household per annum- free. £5 - per book of 10 thereafter. The proposed waiting restrictions and extension of school keep clear markings are intended to remove obstructive parking to improve road safety and promote the free flow of traffic.


The proposed disabled parking bays are intended to benefit disabled people by providing parking bays for the sole use of "blue badge" holders.


The proposed parking amendments in Cygnet Close are intended to benefit residents by increasing the number of residents' permit holder spaces.


The proposed removal of waiting restrictions in part of Elmlea Drive are intended to increase the amount of parking available without compromising road safety.


The proposed extensions to the Heathrow and Ruislip Parking Management Schemes will provide parking for residents, stop non-residential parking and improve road safety.
