- **2. Impose waiting restrictions** in Austin's Lane, Sussex Road & Tavistock Road, Ickenham operational between '9.00am and 5.00pm Monday to Friday' with sections of 'at any time' waiting restrictions to prevent obstructive parking.
- **3. Establish two shared use permit holder or short stay pay & display parking places** near Nos. 1 to 7 Austin's Lane with charges as shown below.
- 4. Extend the existing Zone IC2 permit holder parking place outside Nos. 83 and 85 Burnham Avenue and adjacent to No. 26 Sussex Road.
- 5. Remove the Zone IC2 permit holder parking place outside No. 37 Milverton Drive and replace with '9.00am to 5.00pm Monday to Friday' waiting restrictions.
- 6. Extend the operational times of the Uxbridge North Parking Management Scheme Zone U1 in Braybourne Close, Uxbridge to operate '9.00am to 10.00pm everyday'.






STATEMENT OF REASONS















