2. Install Blue Badge holder disabled parking bays at the following locations:

i) Outside No. 21 Brackenhill, Ruislip

ii) Outside No. 55 Shaldon Drive, Ruislip

iii) Outside No. 55 Wingfield Way, Ruislip

iv) Outside No. 8 Lundy Drive, Hayes

3. Convert the part of the Zone U6 permit holder parking place outside Ivy Leaf Club on How's Road, Uxbridge near the junction with Wellington Road to create a 6.6 metre Blue Badge disabled parking bay.

4. Remove the Zone H1 permit holder parking place outside No. 41 Cranford Lane, Harlington and replace with 'Monday to Saturday 9am to 5pm' waiting restrictions to facilitate the installation of a new vehicle crossing.

5. Remove part of the Zone WD1 permit holder parking place outside No. 3 & 5 Brandville Road, West Drayton and replace with 'Monday to Friday 9am to 5pm' waiting restrictions to facilitate the installation of a new vehicle crossing.

6. Remove part of Zone IC2 permit holder parking place outside No. 2 Clovelly Close, Ickenham and replace with 'Monday to Friday 9am to 5pm' waiting restrictions to facilitate the installation of a new vehicle crossing. Remove a short section of double yellow lines outside No. 2 Clovelly Close so that a parking place can remain.

7. Relocate the Zone IC2 parking place near No. 1 Clovelly Avenue so that is positioned fully in the carriageway.

8. Relocate the Zone IC2 parking place outside Nos. 12 and 14 Milverton Drive so that it is positioned partly on the footway.

9. Extend the existing 'School Keep Clear' markings outside Deanesfield Primary School opposite Nos. 34 to 46 Queens Walk, Ruislip.

10. Install new 'School Keep Clear' markings in School Road, Harmondsworth at the entrance to Harmondsworth Primary School operational 'Monday to Friday 8am to 10pm and 2.30pm to 4.30pm'.

11. Convert the existing 'Monday to Saturday 10.00am to Midday' waiting restrictions on the northwest side of Long Lane in the main carriageway outside Nos. 48 to 56 Long Lane to operate 'Monday to Friday 10.00am to Midday'.

12. Convert the existing 'Monday to Saturday 2.00pm to 4.00pm' waiting restrictions on the southeast side of Long Lane in the main carriageway outside Nos. 27 to 47 Long Lane to operate 'Monday to Friday 2.00pm to 4.00pm'.
