Hillingdon Council gives notice that it intends to make these Orders, which will:

**1. Install a raised road table raised road table 75 mm high with 1:20 gradient ramp at the following locations:**

**i) Judge Heath Lane, Hayes - near the junction with Harlington Road.**

**ii) Princes Park Lane, Hayes - near the junction with Dawley Road.**

**2. Install 'at any time' waiting restrictions on part of the service road fronting Nos. 17 to 23 Falling Lane, Yiewsley** to facilitate a new footway extension in the service road behind the bus shelter and maintain access to Nos. 1 to 15 Falling Lane.

**3. Prohibit vehicles travelling in a south eastbound direction in Harvil Road, Ickenham, on reaching the junction with The Drive, from turning right into The Drive, between 7.00am and 10.00am Monday to Friday.**

**4. Prohibit vehicles travelling in a south eastbound direction in Harvil Road, Ickenham, on reaching the junction with Highfield Drive, from turning right into Highfield Drive, between 7.00am and 10.00am Monday to Friday.**

**5. Add No. 42 Hillingdon Hill to the Uxbridge South Parking Management Scheme Zone U5**

#### STATEMENT OF REASONS



The proposed traffic calming measures in Judge Heath Lane and Princes Park Lane, Hayes are intended to reduce vehicle speeds and promote road safety.


The proposed waiting restrictions on part of the service road fronting Nos. 17 to 23 Falling Lane, Yiewsley will prevent obstructive parking.

The proposed banned right turns are intended to remove rat-running through The Drive and Highfield Drive during the morning peak.
