- 1. Establish permit parking places (operational 'Monday to Friday 8-10am and 2.30-
- **4.30pm')** in which a vehicle may be left during the permitted hours if it displays a valid Zone HE permit in Hewens Road, Uxbridge.
- **2.** Impose waiting restrictions in Hewens Road, Uxbridge operational between 'Monday to Friday 8-10am and 2.30-4.30pm'.
- **3. Impose 'at any time' waiting restrictions** on the junction of Hewens Road and Mellow Lane West, Uxbridge and the junction of Hewens Road and Heath Road, Uxbridge.
- 4. Install a raised road table with a maximum height of 75mm and a 1:15 1:20 gradient on Royal Lane, Uxbridge adjacent to No. 100 Pield Heath Road instead of the previously advertised location between Nos. 123 & 123B Royal Lane.
- 5. Introduce a motorcycle parking place and a disabled parking place on Joel Street, Northwood Hills outside Namaste Lounge.
- 6. Convert the two disabled parking places outside Nos. 17 and 19 Joel Street, Northwood Hills to three Pay & Display parking places.
- 7. Convert the two disabled parking places outside Nos. 78 and 80 Joel Street, Northwood Hills to three Pay & Display parking places.
- 8. Remove the existing motorcycle parking place and three Pay & Display parking places opposite Northwood Hills Underground Station and replace with 'at any time' waiting restrictions.
