5. Covert the existing waiting restrictions to 'at any time' waiting restrictions on the following sections of Hayes End Road, Hayes:

i) West side, between the junction with Uxbridge Road to north of Charolais House.

ii) East side, between the junction with Uxbridge Road to outside Thurbin House. 


### STATEMENT OF REASONS


The proposed 'No Entry' is intended to reinforce the existing one way system in Sharps Lane for vehicles exiting King Edwards Road.




The proposals to introduce disabled parking bays are intended to benefit disabled people by providing a parking bay for the sole use of "blue badge" holders.


































EXPERIMENTAL ORDER 2015 (AMENDMENT NO.1) ORDER 2016 SPOUT LANE NORTH - EXPERIMENTAL PARKING MANAGEMENT SCHEME Hillingdon Council gives notice that it made these experimental Orders under Section 9 of the Road Traffic Regulation Act 1984 on 19<sup>th</sup> February 2016 coming into operation on 2<sup>nd</sup> March 2016, which will:

1. Remove part of the existing 'at any time' waiting and loading restrictions and one Zone H2 permit holder parking place outside Amery Skips, Spout Lane North, and replace with 'Midnight to 7am and 7pm to Midnight' waiting restrictions.

2. Extend the existing Zone H2 permit holder parking place outside No. 8 Spout Lane North by 11.6 metres northeastwards (replacing existing 'at any time' waiting and loading restrictions).

3. Create an additional Zone H2 permit holder parking place (operational 'at any time') on Spout Lane North, to the northeast of the junction with Bedfont Court (replacing existing 'at any time' waiting and loading restrictions).

Applications to the High Court challenging the validity of these Orders should be made within six weeks of the date on which these Orders were made. 
