Hillingdon Council gives notice that it intends to make these Orders which will:

1) Impose 'at any time' waiting restrictions on the sections of road as set out in the Schedule to this notice.

2) Convert the previously proposed limited time waiting restrictions on the section of Ducks Hill Road, Northwood between the junctions of Cygnet Close and Rickmansworth Road to operate 'Monday to Friday 8am to 6.30pm'.

3) Establish permit parking places (operational Monday to Friday 9am to 5pm') in which a vehicle may be left during the permitted hours if it displays a valid U6 permit in Wescott Way and Bettles Close, Uxbridge.

4) Introduce 'Monday to Friday 9am to 5pm' waiting restrictions throughout the rest of Wescott Way and Bettles Close, Uxbridge.

5) Remove a section of Zone IC permit holder parking place to the rear of No. 45 Long Lane in The Paddock, Ickenham and replace with 'Monday to Friday 9am to 5pm' waiting restrictions.

6) Remove a section of Zone H2 permit holder parking place outside No. 490 Bath Road, Heathrow and replace with 'Monday to Friday 9am to 5pm' waiting restrictions.

7) Convert the existing Zone R2 permit holder parking places outside and opposite Nos. 8, 10 & 12 Manor Road and outside Nos. 1 & 3 Manor Road to shared use permit holder or pay & display parking bays - the maximum period for which a vehicle may be left during the permitted hours is two hours, if it displays a valid ticket from a ticket parking machine with charges as shown below.

8) Establish parking places operational 'Monday to Saturday 8.00am and 6.30pm' outside Nos. 825 to 851 Uxbridge Road, Hayes.

a) Pay and display bays - the maximum period for which a vehicle may be left during the permitted hours is two hours, if it displays a valid ticket from a ticket parking machine with charges as shown below.

b) Disabled bay - in which only vehicles displaying a Blue Badge may be left at all times outside Nos. 849 and 851 Uxbridge Road.

SCHEDULE

UXBRIDGE ROAD, HAYES - Extend the existing double yellow lines outside No. 851 Uxbridge Road by 2 metres southeastwards.

LAUREL LANE, WEST DRAYTON - The adopted highway of the access road leading to Laurel Lane Primary School and St Martin's CE Primary School.

HOYLAKE GARDENS, EASTCOTE - Southwest side, from a point in line with the northwestern boundary of No. 11 Hoylake Gardens to a point 4 metres southeast of the northwestern flank wall of No. 13 Hoylake Gardens.

WESCOTT WAY, UXBRIDGE - At the junction with Bettles Close

BETTLES CLOSE, UXBRIDGE - Both sides of the narrow section of road between Bettles Court and No. 40 Westcott Way.

STATEMENT OF REASONS

An extension to the Uxbridge South Parking Management Scheme Zone "U6" in Wescott Way & Bettles Close, Uxbridge will prevent all day non-residential parking whilst still providing parking provision for residents and their visitors.

The revised proposals for Ducks Hill Road are in response to the comments made by local residents during the previous consultation.


The amendments to the parking places outside No. 490 Bath Road, Heathrow and to the rear of No. 45 Long Lane in The Paddock, Ickenham are to facilitate the installation of new vehicle crossings within existing Parking Management Schemes.


The proposals to convert some of the existing permit holder parking places to shared use permit holder or pay & display parking are intended to provide some short stay parking for nearby businesses whilst still maintaining the parking provisions for residents in Manor Road, Ruislip.

The proposals to introduce a 'Stop & Shop' parking scheme operational '8am to 6:30pm Monday to Saturday' outside Nos. 825-851 Uxbridge Road, Hayes End will address shop keepers concerns and prohibit all day parking for the benefits of customers.

The proposed installation of waiting restrictions are intended to remove obstructive parking to assist the free flow of traffic and promote road safety. The proposals have been agreed in principle by the Cabinet Member for Planning, Transportation and Recycling to proceed to formal consultation.









Proposed double yellow lines in the access road leading to Laurel Lane Primary School and St Martin's CE Primary School.


