HAREFIELD HIGH STREET CAR PARK & RUISLIP LIDO - WILLOW LAWN CAR PARK

The Council of the London Borough of Hillingdon in exercise of its powers under Sections 32 and 35 of the Road Traffic Regulation Act 1984 and all other powers enabling it in that behalf intends to make this Order entitled the London Borough of Hillingdon (Off Street Parking Places) Order 1985 (Variation) Order 2015. The purpose of this is to:

1. Designate the off-street parking area to the east of High Street, Harefield as a Car Park, operational between 'Monday to Saturday 8.00am and 6.30pm'. The charges are as follows:

(1)Free of charge on displaying a ticket

2. Designate the off-street parking area northeast of Reservoir Road, Ruislip as the Ruislip Lido - Willow Lawn Car Park. Parking is free of charge.



STATEMENT OF REASONS



PROPOSED WAITING RESTRICTIONS AT VARIOUS LOCATIONS

Hillingdon Council gives notice that it intends to make this Order which will:

1. Impose 'at any time' waiting restrictions on the lengths of road set out in the Schedule to this notice.

2. Impose 'Monday to Friday 8am to 10am and 2.30pm to 4.30pm' waiting restrictions on the west side of Long Lane, Ickenham outside Nos. 80a to 84.

3. Impose 'Monday to Friday 7.30am to 9am' waiting restrictions on the north side of Swakeleys Road, Ickenham outside Nos. 92 to 96.

4. Impose 'Monday to Friday 8am to 10.30am and 2.30pm to 4.30pm' waiting restrictions on the both sides of Potter Street Hill, Northwood - 13 metres north of the junction with Hillside Road to a point in line with the common boundary of La Corbiere and Tresanton.

5. Impose 'Monday to Saturday 8am to 6.30pm' waiting restrictions:

i) On north side of Clayton Road west of the junction with Trevor Road for a distance of 18.29 metres.

ii) On both sides of Trevor Road between the junctions of Clayton Road and Printinghouse Lane.

iii) On the east side of Printinghouse Lane between the junction of Trevor Road and the entrance to Stewart Quay.

6. Remove a section of 'at any time' waiting restrictions outside No. 3 Longmead Road, Hayes.

LONG LANE, ICKENHAM - Between the entrance of the North Hillingdon Centre and northeastern boundary of No. 88 Long Lane.

HILLSIDE ROAD, NORTHWOOD - At the junction with Potter Street Hill.

POTTER STREET HILL, NORTHWOOD - At the junction with Hillside Road.

DAWLISH DRIVE, RUISLIP - At the junction with Dulverton Road.

DULVERTON ROAD, RUISLIP - At the junction with Dawlish Drive.

LANGWORTH DRIVE, HAYES - On the corner outside No. 30 Langworth Drive.

WEST END ROAD, SOUTH RUISLIP - Outside Nos. 352 to 356 West End Road.

PEMBROKE ROAD, RUISLIP - Convert a section of existing 'Monday to Saturday 8am to 6.30pm' waiting restrictions opposite Nos. 23 to 31 Pembroke Road outside London Square Development.

THE COURT, RUISLIP - At the junction with Diamond Road.

DIAMOND ROAD, RUISLIP - At the junction with The Court.

WEALD ROAD, HILLINGDON - At the junction with Long Lane.

LONG LANE, HILLINGDON - At the junction with Weald Road.

YEW AVENUE, YIEWSLEY - At the junction with Fairfield Road.


FAIRFIELD ROAD, YIEWSLEY - At the junction with Yew Avenue.

OXFORD AVENUE, HAYES - On the west side north of the junction of Bath Road and along the southern part of the central island.

TOWNFIELD ROAD, HAYES - At the junction with Fifth Avenue.
GROSVENOR CRESCENT, HILLINGDON - At the junction with Woodcroft Crescent.
WOODCROFT CRESCENT, HILLINGDON - At the junction with Grosvenor Crescent.
QUEENS WALK, RUISLIP - At the junction with Oxford Drive.
OXFORD DRIVE, RUISLIP - At the junction with Queens Walk.
ROWAN ROAD, WEST DRAYTON - At the western most junction with Wise Lane.
WISE LANE, WEST DRAYTON - At the western most junction with Rowan Road.

STATEMENT OF REASONS

The proposed installation of waiting restrictions are intended to remove obstructive parking to assist the free flow of traffic and promote road safety. The removal of waiting restrictions will not compromise road safety, but allow parking for the resident. All proposals have been agreed in principle by the Cabinet Member for Planning, Transportation and Recycling to proceed to formal consultation.
