

- iii) Remove the Zone N permit holder parking place outside No. 34 Murray Road, Northwood and replace with 'Monday to Friday 1pm to 2pm' waiting restrictions.
- iv) Remove the Zone N permit holder parking place outside No. 34 Chester Road, Northwood and replace with 'Monday to Friday 1pm to 2pm' waiting restrictions.
- v) Remove part of the Zone E permit holder parking place outside No. 35 Boldmere Road, Eastcote and replace with 'Monday to Saturday 9am to 5pm' waiting restrictions.
- vi) Remove the Zone H1 permit holder parking place outside No. 28 Pinglestone Close, Heathrow and replace with 'Monday to Saturday 9am to 5pm' waiting restrictions.
- vii) Remove the Zone U5 permit holder parking place outside No. 39 Kings Road, Uxbridge and replace with 'Monday to Friday 9pm to 5pm' waiting restrictions. Copies of the proposed Orders together with plans and the Council's statement of reasons for
