## SCHEDULE WAITING PROHIBITED "AT ANY TIME"

REDMEAD ROAD, HAYES

Southwest side, from a point 5 metres southeast of the southeastern kerbline of Bushey Road to a point 5 metres northwest of the northwestern kerbline of Bushey Road

#### **BUSHEY ROAD, HAYES**

Both sides, from the southwestern kerbline of Redmead Road southwestwards for a distance of 5 metres.

## KEWFERRY ROAD, NORTHWOOD

Northwest side

- i. From a point in line with the southwestern flank wall of No. 1 Kewferry Road northeastwards for a distance of 2.6 metres.
- ii. From a point 4.7 metres northeast of the common boundary of Nos. 7 & 9 Kewferry Road northeastwards to a point opposite a point 10 metres south of the southern kerbline of Harrison Close.

### WAITING PROHIBITED BETWEEN 8AM AND 5PM MONDAY TO FRIDAY



Northwest side



## STATEMENT OF REASONS

The proposed waiting restrictions and School Keep Clear markings are intended to remove obstructive parking to assist the free flow of traffic and promote road safety. All proposals have been agreed by the Cabinet Member for Planning, Transportation and Recycling to proceed to formal consultation.
