WAITING PROHIBITED "AT ANY TIME"

WESTHOLME GARDENS, RUISLIP

Southeast side, from a point in line with common boundary of Nos 13 and 15 Westholme Gardens westwards for a distance of 4.8 metres.

RIVERSIDE WAY, UXBRIDGE

- i. Southern east to west arm, south side, from a point 100.1 metres west of the western kerb line of St Johns Road to a point in line with the eastern kerb line of the western north to south arm of Riverside Way.

WAITING RESTRICTIONS 8AM – 10AM & 2.30 – 4.30PM MONDAY – FRIDAY JUDGE HEATH LANE, HAYES

South side, from a point opposite a point 15 metres east of the eastern kerb line of Commonwealth Avenue to a point in line with western kerb line of Princes Park Lane.

NORTHWOOD WAY NORTHWOOD

- i. Southwest / west / northwest sides, from a point opposite a point in line with the common boundary of Nos 65 and 67 Northwood Way southwards to a point opposite a point 7.8 metres north east of the northern kerb line of Hillside Rise.
