- **2. Impose waiting restrictions** in Merrows Close, operational between 9.00am and 5.00pm Monday to Friday, with "at any time" restrictions around the junction.
- **3. Impose 'at any time' waiting restrictions** in Rickmansworth Road on the southwest side of the road at the junction of Merrows Close between the bus stop and the zebra crossing.

RESIDENTS PERMITS - £0 - 1st vehicle, all subsequent - £40 per annum

VISITORS VOUCHERS First book of 10 per household per annum- free.

£5 - per book of 10 thereafter.


