
#### 1. <u>Recorded data</u>

#### West Area BCU (to 12 July 2020):

BCU incident data shows a decrease from 425 to 380 to last week. This is an increase of seven incidents in the same period last year. Offences of violence with injury have decreased from 60 offences down to 57. This is an increase of nine offences from last year.


In the last 2 weeks there has been an increase of +12.8 in recorded DA offences compared to the same period last year.


#### Please note that the numbers will fluctuate week on week due to late / delayed reporting.



# Hillingdon Borough (data to 12 July 2020):

In the last week, there has been an increase in DA offences from 71 to 80 offences. This is an increase of four offences from the same period last year. VWI offences have increased from 19 to 22 offences. This is an increase of five offences from the previous year.





In addition, it is worth noting that the police data for Hillingdon Borough does NOT include the non-crime element, which invariably would be higher than the recorded DA Offence data.

**Recommendation:** That the wider partnership markets and broadcasts the availability of DA support services on the borough and across London and encourage the safe reporting of DA. Refer to the Local Resources Guide access via <u>https://hillingdon.gov.uk/abuse</u>

#### Metropolitan Police Service (ALL Boroughs) 1 April 2019 – 31 March 2020

Overall there has been a 5.5% increase in recorded crime (of all crime types) – to 912,760 crimes recorded in the Metropolitan Police area in FY 19/20.<sup>1</sup> The sanctioned detection rate was 8.31%

In summary recorded DA offences have increased by 1.85% (to 89,831) and sanctioned detections have reduced by 22.29% to 12,039. This represents a sanctioned detection (conversion) rate of 13.4% (a reduction of 4.17% on FY 18/19). The DA Homicide level reduced from 23 in FY 18/19 to 14 DA Homicides in FY 19/20.

DA Violence with Injury (VWI) reduced from 24,315 recorded offences to 23, 637 in FY 19/20

(-2.79%), of which 4, 1223 offences resulted in a sanctioned detection.

#### Hillingdon Borough

As highlighted in the table below, in Hillingdon, recorded DA offences have reduced by 1.35% to 2,925 (a reduction of 40 offences), which has resulted in 577 sanctioned detections.<sup>2</sup> The SD rate for DA offences is 19.73% (compared to the MPS average of 13.4%).<sup>3</sup>

# Hillingdon IDVA Service

There were 32 referrals of high DA cases to the Hillingdon IDVA Service in the 2 weeks to J<sup>uly</sup> 12th. In the previous 2 weeks there were 44 referrals to this service.

In FY 2019/20 there were 777 referrals to this service. This represents an increase of 3.46% compared to FY 2018/19. This is the highest annual number of referrals managed by this service.

# DA Multi-Agency Risk Assessment Conference (MARAC)

There have 24 high risk cases referred to the DA MARAC in the 2 weeks to July 12th compared to 32 referrals for the previous 2 weeks. The next 'remote' MARAC meeting is taking place on July 16<sup>th</sup>.

The SafeLives data for FY 19/20 (April to March) shows that our local MARAC managed 518 referrals, which is an 11% increase. This compares to a London average increase of 4%.

## Multi-Agency Safeguarding Hub (MASH)

In the 2 weeks to July 12th the MASH has received 119 MERLIN reports with a Domestic Abuse safeguarding element, of which 90 involved children. In the previous 2 weeks there were 117 Merlin referrals, of which there were 90 involving children. Overall there is a 20 - 25% increase in Merlin reports received in the MASH.


We would welcome your contributions, support and involvement in the above work.
