PROPOSED 'AT ANY TIME' WAITING RESTRICTIONS

ACER AVENUE, HAYES - At the junction with Jollys Lane.

JOLLYS LANE, HAYES - At the junction with Acer Avenue.

AIRDRIE CLOSE, HAYES - Extend the existing double yellow lines to outside Nos. 1 to 4 Airdrie Close. GLENCOE ROAD, HAYES - Extend the existing double yellow lines east of the junction with Airdrie Close by 10 metres.

DENZILOE AVENUE, HILLINGDON - Extend the existing double yellow lines adjacent to No. 27 New Broadway, Uxbridge Road, northward to a point opposite No. 6 Denziloe Avenue.

FAIRHOLME CRESCENT, HAYES - Extend the existing double yellow lines throughout all of the access road between Nos. 108 and 110 Fairholme Crescent.

MELLOW LANE WEST, HILLINGDON - Extend the existing double yellow lines west of the junction with Hewens Road by 13 metres.

MORRIS AVENUE, UXBRIDGE - At the junction and to the limit of the adopted highway of the access road leading to Nos.14 to 20 Morris Avenue.


OWEN ROAD, HAYES - On the inside of the corner near No. 3 Owen Road.


TOWNFIELD ROAD, HAYES - At the junction with Sixth Avenue.


SIXTH AVENUE, HAYES - At the junction with Townfield Road.

STATEMENT OF REASONS



The Council of the London Borough of Hillingdon, after consulting the Commissioner of Police of the Metropolis in exercise of the powers conferred by Section 6 and 124 of and part IV of Schedule 9 to the Road Traffic Regulation Act 1984¹ as amended by Section 8 and Schedule 5 of the Local Government Act 1985², the Road Traffic Act 1991³ and of all other enabling powers hereby make the following Order:-

- 1. This Order shall come into operation on ???????? and may be cited as the Hillingdon (Waiting and Loading Restriction) (Consolidation) Order 1994 (Amendment No. ???) Order 2020.
- 2. In this Order the expression "enactment" means any enactment, whether public, general or local, and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Hillingdon (Waiting and Loading Restriction) (Consolidation) Order 1994⁴ shall have effect as though the items numbered 1365, 1283, 832, 742, 404, 1461, 1340, 1089, 759
