



STATEMENT OF REASONS


The proposal is to provide a right turn filter lane to allow for proposed increased number of right and left turning movements from North Hyde Road, Hayes into Harold Avenue and then into Nestle Avenue. In order to achieve this the alignment of North Hyde Road and Harold Avenue needs to be revised.

- THE CONTRACTOR SHALL ALLOW FOR THE PROTECTION, TEMPORARY AND PERMANENT SUPPORT AND DIVERSION WORKS AS NECESSARY, TO ALL EXISTING SERVICES TO THE SATISFACTION OF THE PUBLIC UTILITIES.

- ALL DIMENSIONS ARE TO BE CHECKED ON THE SITE BEFORE THE COMMENCEMENT OF WORKS. ANY DISCREPANCIES ARE TO BE REPORTED TO THE ARCHITECT AND ENGINEER FOR VERIFICATION. FIGURED DIMENSIONS ONLY ARE TO BE TAKEN FROM THIS DRAWING.
- ALL TRAFFIC SIGNS AND ROAD MARKINGS TO COMPLY WITH 'THE TRAFFIC SIGNS AND GENERAL DIRECTIONS 1994' AND CHAPTER 5 OF THE 'TRAFFIC SIGNS MANUAL'.
- THERMOPLASTIC MATERIAL IS TO BE APPLIED BY HAND OR MECHANICAL APPLICATOR.

The Council of the London Borough of Hillingdon, after consulting the Commissioner of Police of the Metropolis in exercise of the powers conferred by Section 6 and 124 of and part IV of Schedule 9 to the Road Traffic Regulation Act 1984¹ as amended by Section 8 and Schedule 5 of the Local Government Act 1985², the Road Traffic Act 1991³ and of all other enabling powers hereby make the following Order:-

- 2. In this Order the expression "enactment" means any enactment, whether public, general or local, and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - i) Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Hillingdon (Waiting & Loading Restrictions) Order 2021⁴ shall have effect as though the item numbered 131 in Schedule 1 of that Order was substituted by the
