#### DATA PROTECTION PRIVACY NOTICE FOR Universal Youth Service

# Why are we providing this Notice to you

The Council, in its capacity of Data Controller, holds certain information about you ["personal data"] which it needs to process for the purpose of providing the Universal Youth Service. This Notice is designed to give you information about the personal data we hold about you, how we will use it, your rights in relation to it and the safeguards that are in place to protect it.

#### What personal data do we hold

As a member of the Universal Youth Service, the types of data we hold and process will typically include:

- Personal information of the child or young person including name, address, email, phone number, ethnicity, medical and support needs;
- Next of kin details including name, address and telephone numbers;
- Children;
- Personal information that will help us deliver care and support for the child or young person using our service;

The above data is obtained directly from you when you join and when you provide updates. We obtain some of this data directly from you and we may also obtain it from other sources. Where this is the case, we will set out in this notice the identity and the contact details of the relevant data controller and also the contact details of their data protection officer.

# What is our purpose for processing your personal data

We process your personal data to enable children and young people to access our services and to support their needs whilst using services.

The data is collected through completing membership forms and booking through the London Borough of Hillingdon FIESTA programme.

If we intend to process your personal data for a purpose other than that for which the personal data was collected, we shall provide you details of that other purpose before we start processing your data.

#### What is the legal basis for our use of your personal data

• We have obtained your freely given and specific consent and have informed you that you have the right to withdraw it at any time

## What we do if your personal data is sensitive

We will only process your sensitive personal data with your consent, unless we can lawfully process it for another reason permitted by law. We will notify you if it is sensitive and as with non-sensitive personal data, you have the right to withdraw your consent to processing at any time by letting us know. Sensitive data is data revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, trade-union membership, genetic and biometric data, data concerning health or data concerning a natural persons sex life or sexual orientation.

#### For how long will we hold your personal data

We will only keep your personal data for as long as we need to in order to fulfil the purpose[s] for which it is collected and for so long afterwards as we consider it may be required to deal with any questions or complaints about the service which we provide to you, unless we elect to retain your data for a longer period in order to comply with our legal and regulatory obligations.

### Organisations that we may share your personal data with

The circumstances in which the Council may do this are set out in the Council's Generic Data Protection Privacy Notice.

The Universal Youth Service will only share personal data about children and young people in line with our statutory obligations for child protection or safeguarding.

### Your rights

You have a right to access and obtain a copy of the personal data that we hold about you and to ask us to correct your personal data if there are any errors or it is out of date. In some circumstances, you may also have a right to ask us to restrict processing of your data until any errors are corrected, to object to processing or to transfer or [in very limited circumstances] erase your personal data. If you wish to exercise any of these rights, please contact Dettie Quirke. We may from time to time ask for further information from you. If you do not provide such information, or ask that the personal data we already hold is deleted or restricted, this may affect the service that we provide to you.

We may update this notice periodically. Where we do this, we will inform you of the changes and the date on which the changes take effect.
