Thank you once again to every resident who has got involved with the consultation and the resident ballot.

We are delighted to receive the support from residents to move forward with the proposals for the estate.

As you will be aware, **79%** of residents that voted, **voted YES** for redevelopment.

This newsletter provides you with a project update, the next steps for consultation, and how and where you can come to speak to us.

We look forward to seeing you soon.

Hillingdon Council held a Cabinet meeting on 17 June which agreed the next stages of funding to help make the project happen. The next step is to work towards submitting a planning application later this year so that we can begin the first phase in autumn 2022.

You may receive some letters from the council over the coming weeks, including a 'demolition notice'. We want to reassure you that these are nothing to be worried about. They are part of the procedure required to redevelop the estate.

Do contact us if you have any concerns or need something explained.



As a reminder, do get in touch to begin the Buy Back process if you are a resident leaseholder in a later demolition phase and would like to sell your property early.

We have already started talking to residents in the first phase of the demolition to get a clearer understanding of their needs and aspirations.

Everyone's needs are different, and while some residents have told us that they wish to remain on the estate, others have said they would like to move away permanently to other parts of the borough or other parts of the UK.

We are pleased to announce that we now have a dedicated team for residents to contact to discuss any matters relating to moving off the estate. Please see the contact details section for more information.

It has been great to hear the excitement about the future estate. We know residents have lots of questions about what happens next and when, about pets, what to do about bulky items they no longer need and wish to donate to charity, and many more.
