In particular, the Services (Housing / Public Committee was encouraged by the effective use of 29 January 2014 Health) zero based budgeting and ongoing work in relation to the preventative agenda so that informed decisions were taken to mitigate future risks. The Committee acknowledged there may be a number of potential barriers in relation to the implementation of the Care Bill given the details which are still emerging, but were reassured that the Council's Programme Board had been established to examine the impact of the Bill on Hillingdon. Committee were concerned about the overspend particularly in relation to Bed and but welcomed the Breakfast accommodation, ongoing work being conducted through the Hillingdon Improvement Programme to bring this back to sustainable levels. The Committee also congratulated officers on their market development work, in recognising the need for affordable housing and the actions that were being taken to increase this provision. Additionally, the Committee noted the successful redesign of services and the emphasis placed on the risk stratification process so that interventions are made earlier. The Committee also noted the importance of effective monitoring to ensure that early interventions result in better, and sustained, outcomes for residents as well as supporting service management. The Committee welcomed the merger of the Rapid Response and Re-ablement Teams and the further work being conducted to support people to live independently in their own homes.
