**1.** Introduce seasonal parking charges as shown below within the indicated spaces within Breakspear Crematorium Car Park, between '10am to 7pm Saturday, Sunday, Bank & Public Holidays between 1<sup>st</sup> May and 1<sup>st</sup> September'.

## 2. Designate the parking area in front of Breakspear Crematorium Cottages and The Lodge, Breakspear Road, Ruislip as a car park:

i) For the use of 'Breakspear Crematorium' permit holders only within the existing marked bays.ii) For the use of blue badge holders within the existing marked disabled bays.

The Council of the London Borough of Hillingdon, after consulting the Commissioner of Police of the Metropolis, in the exercise of the powers conferred by Sections 6, 9, 32, 35 (1 & 3), 124 and part IV of Schedule 9 to the Road Traffic Regulation act 1984<sup>1</sup> as amended by Section 8 and Schedule 5 of the Local Government Act 1985<sup>2</sup>, the Road Traffic Act 1991<sup>3</sup>, Parts III and IV of Schedule 9 to the Act and Section 115 of the Highways Act 1980 and of all other powers enabling hereby makes the following Order:-

 This Order shall come into operation on 25<sup>th</sup> April 2022 and may be cited as The Hillingdon (Off Street Parking Places) Order 1985 (Amendment No. 2) Experimental Order 2022.

#### 2. INTERPRETATION

In this Order:

a) The expression "Order of 1985" means the London Borough of Hillingdon (Off Street Parking Places Order) 1985 as amended by the Variation and amendment Orders;

b) The description "Breakspear Crematorium Car Park" means that area shown edged in red on the plan titled "Breakspear Crematorium Car Park".

c) The description "Breakspear Crematorium Cottages Car Park" means that area shown edged in red on the plan titled "Breakspear Crematorium Cottages Car Park".

#### 3. AMENDMENT TO THE ORDER

The London Borough of Hillingdon (Off Street Parking Places) Order 1985 shall have effect as though:-

a) There was added to the Schedule to that Order the schedule relating to Breakspear Crematorium Car Park as set out in Schedule 1 of this Order;
b) There was added to the Schedule to that Order the schedule relating to Breakspear Crematorium Cottages Car Park as set out in Schedule 2 of this Order;

c) There was added to that Order the plan titled "Breakspear Crematorium Car Park" attached to this Order.

d) There was added to that Order the plan titled "Breakspear

Crematorium Cottages Car Park" attached to this Order.

e) There was added to Article 2(1) of that Order:-

"Breakspear Crematorium Permit" means a permit issued by the council for use in designated permit holder bays.

f) There was added to Article 3 of that Order a sub item:

(7) No person shall cause or permit any vehicle to park in a designated "Breakspear Crematorium Permit Holder Only" bay unless a "Breakspear Crematorium Permit" is displayed on the vehicle.

4. In pursuance of Section 10(2) of the Road Traffic Regulation Act 1984, the Corporate Director of Place of the London Borough of Hillingdon, for the time being, or some other person authorised in that behalf by him, may, if it appears to him or that person essential in the interests of the expeditious convenient and safe movement of traffic or for preserving or improving the amenities of the area or any road affected by this Order, modify or suspend this Order or any provision thereof.


