- vi) Outside No. 41 Longmead Road, Hayes (with two wheels on the footway)
- vii)Outside No. 47 Campbell Close, Ruislip
- viii) Outside No. 21 Wordsworth Way, West Drayton

3. Convert a section of Zone RM2 permit holder parking place outside No. 15 Green Walk, Ruislip to a blue badge disabled parking bay.

4. Convert a section of Zone U6 permit holder parking place outside Nos. 163 and 162 Waterloo Road, Uxbridge to a blue badge disabled parking bay.

5. Convert a section of Zone WD7 permit holder parking place outside Nos. 64

Harmondsworth Road, West Drayton to a blue badge disabled parking bay.

6. Convert the redundant blue badge disabled parking bay outside No. 57 Blyth Road, Hayes to Zone HY1 permit holder parking place.

7. Convert the redundant blue badge disabled parking bay outside No. 165 Waterloo Road, Uxbridge to Zone U6 permit holder parking place.

#### 8. Remove the following redundant disabled parking bays at the following locations:

i) Outside No. 86 Dawlish Drive, Ruislip

ii) Outside No. 104 Wentworth Crescent, Hayes

- iii) Outside No. 167 Beverley Road, Ruislip
- iv) Outside No. 11 Mead Way, Ruislip
- v) Outside No. 36 Richmond Avenue, Hillingdon
- vi) Outside Gurney House, Croyde Avenue, Hayes
- vii) Outside No. 26 Brickett Close, Ruislip
- viii) Outside No. 5 Bempton Drive, Ruislip

9. Install limited time waiting restrictions operational 'Monday to Friday 8am to 10am and 2.30pm to 4.30pm' on Rowan Road, West Drayton opposite the junction with Wise Lane near Nos. 140 and 142 Rowan Road.

10. Install waiting restrictions operational '10am to 7pm Saturday, Sunday, Bank & Public Holidays between 1<sup>st</sup> May and 1<sup>st</sup> September' outside Nos. 9 and 10 Breakspear Road, Ruislip.

11. Convert sections of the existing limited time waiting restrictions to 'at any time' waiting restrictions on the section of Tavistock Road, Yiewsley between the zebra crossing west of the junction with High Street up to the pay & display parking bays west of the junction with Garnet Place.

12. Convert the section of existing limited time waiting restrictions to 'at any time' waiting restrictions outside Nos. 5 to 11 Mendip Close, Hayes.

13. Convert the section of existing limited time waiting restrictions to 'at any time' waiting restrictions between Nos. 1 & 2 and Nos. 3 & 4 Grampian Close, Hayes.

14. Install pairs of 75mm high speed cushions with 1:20 gradient ramps on each approach at the following locations:

i) Outside No. 136A Vine Lane, Uxbridge

ii) Adjacent to No. 2 Chestwood Grove on Vine Lane, Uxbridge

iii) Outside No. 120 Vine Lane, Uxbridge

# 15. Install raised road tables 75mm high with 1:20 gradient ramps on each approach at the following locations:

i) Outside the electrical substation next to No. 91 Cherry Lane, West Drayton

ii) Outside No. 69 Cherry Lane, West Drayton

iii) Outside No. 39 Cherry Lane, West Drayton

iv) Outside No. 23 Cherry Lane, West Drayton

**16.** Remove the sections of double yellow lines on Breakspear Road, Ruislip across the two vehicle crossovers opposite the junction with Withy Lane leading to Orchard Dell. 
#### STATEMENT OF REASONS






The proposed amendments for Breakspear Road, Ruislip are as a result of comments received from residents and businesses during consultation or shortly after the scheme was introduced.


All proposals have been agreed in principle by the Cabinet Member for Public Safety and Transport to proceed to formal consultation.


































































The Council of the London Borough of Hillingdon, after consulting the Commissioner of Police of the Metropolis in exercise of the powers conferred by Section 6 and 124 of and part IV of Schedule 9 to the Road Traffic Regulation Act 1984<sup>1</sup> as amended by Section 8 and Schedule 5 of the Local Government Act 1985<sup>2</sup>, the Road Traffic Act 1991<sup>3</sup> and of all other enabling powers hereby make the following Order:-
